PHILOSOPHY

Nursing fosters the promotion, maintenance, and restoration of health in diverse communities across the lifespan. As a professional discipline, nursing entails both independent and collaborative care and is based on caring behaviors, scientific knowledge, ethical-legal principles, clinical competencies, the nursing process and clinical decision making. WATTS COLLEGE OF NURSING - BSN PROGRAM OBJECTIVES

1. Manage client-centered care, utilizing the nursing process, to meet the spectrum of health care needs of a diverse population across the lifespan.
2. Collaborate with clients, families, communities, and health team members in the promotion, maintenance, and restoration of optimal health.
3. Demonstrate professional accountability and commitment to compliance with professional performance standards of the ANA including quality, nursing practice, education, leadership, and research.
4. Provide safe and effective care, justifying clinical decision-making based on evidence from nursing and associated disciplines.
5. Manage informational and technological resources to coordinate, facilitate, and improve the quality and delivery of health care in a variety of settings.

EDUCATIONAL EFFECTIVENESS

Graduates of the College of Nursing are eligible to apply for the NCLEX exam for licensure as a registered nurse. Prior to graduation, senior students take a comprehensive assessment test, which measures the student's probability of a passing performance on the NCLEX-RN.

Our graduates enjoy many employment opportunities, including pediatrics, critical care/trauma units, maternity nursing and all areas of medical-surgical nursing. They feel prepared to accept the challenges of all phases of nursing due to the strong clinical component of the program. Employers also appreciate the beginning competencies of our graduates.

PROGRAM OF STUDY

Watts College of Nursing offers a two-year program of study leading to a Bachelor of Science in Nursing. Students complete and transfer in 60 credit hours of the general education courses required prior to matriculation into the nursing program.

METHOD OF DELIVERY: RESIDENTIAL AND BLENDED

All coursework is conducted within the program at 2828 Croasdaile Drive, Durham, NC, via in-person, online delivery or at an approved clinical affiliate location.

ADMISSION INFORMATION

The Watts College of Nursing is solely responsible for admission of students into the program. The College seeks to maintain a diverse student population, which is motivated and committed to the professional practice of nursing. The ideal applicant will demonstrate a good academic history, intellect to succeed in the program, and service to others.

Meeting Watts' minimum requirements does not guarantee acceptance into the College. Individual consideration is given to each applicant. If not accepted, an applicant may reapply only once.

Watts College of Nursing reserves the right to withdraw the acceptance of any student to the program.

ADMISSION PROCESS

There are four steps to the admissions process: transcript evaluation, apply, application review, and admission.

Step 1: Transcript Evaluation - Request a transcript evaluation by emailing unofficial transcript(s) to wconregistrar@duke.edu. In return, the College will provide you with a confirmation of transferrable courses.

Step 2: Apply - Applicants who have completed or in the process of completing 45 credit hours of the required general education courses, and received approval of these credit hours by the College submits application.

Step 3: Application Review - The Student Affairs Committee reviews applications for acceptance following the applicant's passage of the HESI A2 exam, and receipt of specified materials listed under Step 2 Admission Requirements.

Step 4: Admission - is granted to the applicant upon completion, review and approval of all 60 credit hours. The applicant must also meet all admission requirements for matriculation into the nursing division.

A letter of intent and enrollment fee is due upon notification of acceptance.

Once accepted, a student may request to delay matriculation one semester. Those with special circumstances may request an extension of this time period from the Student Affairs Committee. Any further delay will necessitate reapplication to the College.

The Coordinator of Student Affairs must receive official transcripts verifying successful completion of the general education courses prior to the first day of orientation. Students with missing official transcripts will not be allowed to attend orientation and matriculate into the nursing division.

ADMISSION REQUIREMENTS

All of the admission requirements must be completed prior to the first day of orientation.

- United States Citizen or United States Lawful Permanent Resident proof
- Submit Watts College of Nursing Application and pay application fee
- Accept Technical Standards Agreement Form in application
- Submit Plan for Completion of General Education Requirements Form
- Submit References - one academic/one professional or two academic
- Submit unofficial college transcripts for the review process

Step 3: Submit/complete the following

- Create an Evolve student account, register for the Distance Testing Exam (HESI A2), and pass at the designated level

- Submit letter of intent and enrollment fee upon notification of acceptance
- Complete any remaining general education credits
- Complete criminal background application*
- Submit WCON Medical Form

ADMISSION INFORMATION

- Submit to alcohol and drug testing* prior to matriculation in the program
- Submit official college transcripts for any remaining general education credits
- Submit official high school transcript, diploma, or GED certificate
- Submit proof of current Basic Life Support (BLS) training through the American Heart Association (BLS Provider Course)*
- Submit proof of health insurance*
- Purchase of uniform from approved vendor*

*Costs are the responsibility of the student

PREADMISSION TESTING

Prospective applicants must take the HESI Admission Assessment Exam (HESI A2), an assessment tool used to evaluate academic readiness and individual potential for successful program completion. The required tests are English Language (Reading Comprehension, Vocabulary and General Knowledge, Grammar), and Math. A fee is charged for the test, which is administered at Prometric test centers located throughout the United States.

An applicant must pass at the designated level, a mean score for English of 75 (average of all 3 English sections) and a score of 70 for Math.

An applicant can take the exam a maximum of two times every 12 months. Only test scores within the last 24 months will be considered.

REFERENCES

Two references are required from individuals (one academic/one professional or two academic) who have known the applicant long enough to be familiar with their qualifications, particularly those which relate to the applicant's suitability for nursing.

GENERAL EDUCATION REQUIREMENTS

The College requires that specified general education requirements be taken from an accredited institution of

higher learning (i.e., junior college, technical/community college or four year college or university).

All 60 credit hours of the general education courses required must be completed prior to matriculation into the nursing program.

Each course must be passed with the minimum grade and number of credit hours indicated below prior to beginning the nursing program at Watts College of Nursing:

- English Composition I (C) 3 semester hours
- English Composition II (C) 3 semester hours
- Literature (C) 3 semester hours
- Speech Communication/Public Speaking (C) 3 semester hours
- Anatomy and Physiology I with a lab (C) 4 semester hours
- Anatomy and Physiology II with a lab (C) 4 semester hours
- Human Anatomy and Physiology must cover all body systems, and be taken within five years of the date of matriculation into the nursing curriculum
- Microbiology with a lab (C) 4 semester hours
- Biology with a lab (C) 4 semester hours
- Chemistry with a lab (C) 4 semester hours
- Nutrition (C) 3 semester hours
- Fine Arts/Humanities (C) 7 semester hours
- College Math (C) 3 semester hours
- Statistics (C) 3 semester hours
- Introduction to Psychology (C) 3 semester hours
- Human Growth and Development (C) 3 semester hours
- Human Growth and Development must cover the lifespan
- Introduction to Sociology (C) 3 semester hours
- History (C) 3 semester hours

TRANSCRIPTS

Each applicant must arrange for official college transcripts to be sent to the College of Nursing by all schools previously attended.

ADMISSION INFORMATION

CRIMINAL BACKGROUND CHECK

A criminal background check is completed as part of the admissions process to Watts College of Nursing.

A Criminal Background Check Report that indicates no record allows the applicant to continue with the admissions process.

A Criminal Background Check Report that indicates a record will be reviewed on an individual basis.

- Charges dismissed/no conviction allows the applicant to continue with the admissions process.
- A conviction greater than five years with all components satisfied allows the applicant to continue with the admissions process. Should the conviction have an effect on safe practice, the Student Affairs Committee will review.
- A conviction less than five years will be reviewed on an individual basis by the Student Affairs Committee.
- Any decision made by the Student Affairs Committee is final.

INTERVIEW

Watts College of Nursing reserves the right to interview and interface with an applicant in determining eligibility for acceptance.

HEALTH INSURANCE

All students are required to show proof of health insurance prior to matriculation (Step 4) into the nursing program and to maintain health insurance while enrolled at Watts College of Nursing.

PHYSICAL AND EMOTIONAL HEALTH

The applicant must, in the judgment of Watts College of Nursing, be able to function as a nursing student. Following acceptance, applicants will receive a medical form for completion by their personal physician. The form must be completed and returned to the College of Nursing prior to enrollment in the nursing curriculum. Failure to return the completed medical form by the deadline given will result in the withdrawal of acceptance and the student will not be able to begin the nursing program.

The Employee Occupational Health and Wellness Office of Duke Regional Hospital screens all students. It should be noted that a chronic health problem could indicate the potential for non-matriculation.

ALCOHOL AND DRUG TESTING

Watts College of Nursing believes that having a drug free environment is necessary to accomplish its mission. To ensure the health and safety of patients, all students must submit to alcohol and drug testing prior to matriculation in the program. Refusal to participate in the required testing or a confirmed positive test will result in the withdrawal of acceptance and the student will not be able to begin the nursing curriculum.

GUIDELINES

- The cost of alcohol and drug testing is the responsibility of the student and will be paid directly to the approved vendor.
- Students will be tested for alcohol and the following drug groups: Amphetamine, Methamphetamine, Barbiturates, Benzodiazepines, THC, Cocaine, Opiates, Methadone, Oxycodone, Propoxyphene, PCP, and MDMA (Ecstasy). This list of drugs is subject to change. Testing for additional substances may occur based on clinical affiliation agreements.
- The student must provide written consent to provide specimens for the purpose of analysis. If the student is under eighteen (18) years of age, the student's parent or legal guardian must sign the alcohol and drug testing consent form in addition to the student. The signed consent must be returned to the Coordinator of Student Affairs.
- The signed consent form will be maintained in the admission record.
- Students will be provided with directions for alcohol and drug testing and assigned a specific deadline date. Students who do not adhere to the deadline date given jeopardize acceptance in the program.
- For a negative alcohol and drug screen, no action is taken.

ADMISSION INFORMATION

- Any positive test result shall be confirmed by the testing lab and reviewed by the vendor's Medical Review Officer (MRO) who will contact the student directly to discuss the positive test result and obtain information.
- A student with a positive test result may request a retest. Cost of retesting is the responsibility of the student and will be paid directly to the approved vendor. Upon notification of a positive test result, the student has three (3) business days to request a retest and the request must be made via telephone or in writing to the vendor's MRO. The same specimen is sent to a new lab for retesting.
- Written notification indicating either a positive or negative test result shall be sent to Watts College of Nursing. Test results will not be released to any individual who has not been authorized to receive such results.
- Results of the drug testing will be kept in the student admission file and provided to contracted clinical agencies only when required by clinical affiliation agreements.

COMPUTER

All entering students are required to have their own personal portable electronic device (i.e., Laptop, iPad, does not include phones) and responsible for maintaining the software, hardware, and upgrades required for course and communication requirements.

INTERNATIONAL STUDENTS

Watts College of Nursing accepts only United States Citizens and United States Lawful Permanent Residents.

Students originally from outside of the United States, and/or whose native language is not English are considered international students.

Translation of official transcripts from all colleges/universities attended into English is required. It is the responsibility of the international applicant to see that transcripts are evaluated through WES (World Education Services, www.wes.org), an independent academic credential services organization.

All applicants who do not have English as their native language must take the TOEFL iBT (Test of English as a Foreign Language Internet-based Test). A total score of 100, with a minimum of 25 for each section is required.

TECHNICAL STANDARDS

Students accepted into the Watts College of Nursing with or without reasonable accommodations are expected to have the technical abilities necessary to effectively and safely perform the requirements of a student nurse.

BASIC LIFE SUPPORT TRAINING (BLS)

It is the responsibility of the student entering Watts to obtain and maintain current BLS training. This training must be obtained from the American Heart Association at the BLS Provider Course level. (It is not necessary to have BLS training when first applying.)

READMISSION OF FORMER STUDENTS

Students who were enrolled in the BSN nursing curriculum and withdrew from the program and eligible for readmission are allowed to apply for readmission only once. Former students must meet all current admission requirements. Time limits on general education courses and total number of semesters of study apply. Credit for prior nursing courses will be granted as determined by the faculty. A student dismissed from Watts College of Nursing is ineligible for readmission.

ADMISSION INFORMATION

TRANSFER OF CREDIT

Watts College of Nursing (WCON) accepts transfer credit from only accredited post-secondary institutions. Upon conditional acceptance; a student's transcript(s) will be initially reviewed for approval of transfer credit. The curriculum does not offer advanced placement for LPNs. Challenging or auditing a course is not permitted.

GENERAL EDUCATION REQUIREMENTS

Each course must be passed with the minimum grade, number of credit hours, and meet the specified content and time frames required.

COLLEGE BOARD ADVANCED PLACEMENT EXAMINATIONS

Watts College of Nursing awards transfer credit for approved College Board Advanced Placement (AP) Examinations. The minimum score required is 3.

NURSING COURSES

Watts College of Nursing limits transfer credit for nursing courses from other accredited and approved Registered Nurse (RN) nursing programs to no more than 30 credit hours. The final two semesters of nursing must be completed at Watts College of Nursing. A transfer course must be comparable in content and competencies. Attainment of a course grade of "C" or above is necessary. A course syllabus and summary of clinical evaluation are required to grant credit, which is determined on an individual basis.

- A summary of clinical evaluation is requested with official transcripts from the accredited and approved school of nursing
- A course syllabus for all completed nursing courses must accompany the school transcript.
- Attainment of a course grade of "C" or above for each course approved for transfer and satisfactory clinical performance grades are necessary for transfer of course credit.
- It is required that the two references be from faculty members of the school of nursing.

TRANSFER STUDENTS

Applicants from other accredited and approved (RN) nursing programs may apply for transfer admission.

All admission requirements are applicable to the transfer student along with the following additional information:

- The transfer applicant must submit a personal letter stating the reason(s) for requesting the transfer. It should accompany the application for admission.

Transfer applications cannot be reviewed until all materials have been received.

Placement within the Watts College of Nursing is determined on an individual basis according to established policy and space availability.

Upon acceptance, the applicant may request a review of nursing courses for transfer credit. There is a processing fee for review and placement services for transfer students.

Students must meet all financial obligations to the College before progressing to the next course unless financial aid is pending. The deadline for submitting a payment for learning resources will be determined by the course faculty. Students who fail to meet all financial obligations to the College will not be able to enroll in the next course and/or receive an official course grade or transcript(s). Senior students who do not meet all financial obligations to the College and/or vendor prior to graduation will not receive an official course grade, diploma, transcript(s), or verification(s). Students unable to meet financial obligations will be subject to dismissal.

Watts College of Nursing accepts payment in the form of a cashier's check or money order.

DEFINITIONS:

Tuition - Charges for semester hour credit for classroom and clinical instruction

Fees - Charges for cost related to resources and activities of the College

POLICY

During the budget preparation period tuition and fees will be reviewed, assessed, and determined annually.

Tuition is determined by credit hour cost per course per semester.

All students will be charged the same amount for tuition.

Fees are determined for the required resources and activities that support the educational endeavors of the College.

Fees are per semester and may vary based on the semester's required resources and activities.

All tuition and fees are due prior to the first day of class.

FINANCIAL INFORMATION

No payment plan will be offered.

Any student receiving financial aid will be required to present an "Award Letter" prior to the first day of class indicating the amount of financial aid to be received. Any remaining balance is due prior to the first day of class.

A student will be permitted to attend class only when a zero balance for both tuition and fees (pending financial aid) has been met.

Students who fail to meet all financial obligations to the College will not be able to enroll in the next course and/or receive an official course grade or transcript(s) and must complete the Exit Clearance Form.

Senior students who do not meet all financial obligations to the College prior to graduation will not receive an official course grade, diploma, transcript(s), or verification(s).

The College reserves the right to make changes to the tuition and fees. Students will be given notice of at least 30 days prior to the change.

On or before July of each year, students will be notified of the tuition and fees for the upcoming academic year (Fall and Spring Semesters).

At any time during enrollment, students unable to meet financial obligations will be subject to dismissal.

REFUNDS

DEFINITIONS:

Drop a course - Dropping a course by student request before the Add/Drop Deadline.

Add/Drop Deadline - The Add/Drop Deadline is the Friday of the second week of classes.

Course Withdrawal - Withdrawal from a course by student request after Add/Drop Deadline. The deadline for a course withdrawal is at the end of the tenth week of the semester.

Program Withdrawal - Withdrawal from the program (all courses) by student request or administrative action with or without the ability to apply for readmission. The deadline for a program withdrawal by student request is by the end of the tenth week of the semester. Administration reserves the right to issue an administrative withdrawal to remove a student at any point in the program.

POLICY:

Watts College of Nursing (WCON) recognizes that a student may need to withdraw from a course or the program for various reasons.

When requesting to withdraw from a course(s) or the program, it is required that the student meet with the Financial Counselor to make adjustments in financial aid and with WCON Administration to arrange payment of all financial obligations to the college.

PROCEDURE:

The last day of attendance is noted as the last date of activity (participation) in the course and/or program.

Withdrawal from a Course

Students who withdraw from a course may repeat that course only once. A maximum of two courses may be repeated within the program.

The Coordinator of Registration and Enrollment will record the appropriate designation(s) on the student transcript:

- (WP) Withdrew Passing from Course
- (WF) Withdrew Failing from Course

A student desiring to withdraw from a course must:

- Meet with the Lead instructor, discuss the decision to withdraw from the course, and complete the Course Withdrawal Form
- Meet with Administration to review the Course Withdrawal Form
- Meet with the Financial Counselor and WCON Administration to make adjustments in financial aid and to arrange payment of all financial obligations to the college
- Meet with the Coordinator of Registration and Enrollment and submit the Course Withdrawal Form
- Contact Administration by the last day of the semester withdrawn from to indicate plan to re-enroll in course(s)
- Understand that failure to notify Administration of intent to re-enroll will result in administrative withdrawal from the program
- Contact Administration for semester start date

FINANCIAL INFORMATION

- (Note: If the course(s) withdrawal brings the student below full-time status, this will disqualify them from receiving full-time financial aid, then the student must decide and contact administration whether to become a self-pay student or withdraw from the program)

Withdrawal from Program

The Coordinator of Registration and Enrollment will record the appropriate designation(s) on the student transcript.

The student record will indicate that the student withdrew from the program or if an administrative withdrawal was issued and whether the student is eligible for readmission.

- (WE) Program Withdrawal, Eligible for Readmission
- (WI) Program Withdrawal, Ineligible for Readmission

A student desiring to withdraw from the program must:

- Meet with Administration to discuss the decision to withdraw from the program, complete the Program Withdrawal Form, and exit interview
- Return assistive learning devices to Administration and obtain signatures (as required) (***Failure to return assigned materials will result in a charge for the item(s)**)
- Meet with the Financial Counselor to make adjustments in financial aid and WCON Administration to arrange payment of all financial obligations to the college
- Meet with the Coordinator of Registration and Enrollment and submit the Program Withdrawal Form, identification badge (ID) and security badge

The student will be charged for the entire 15-week semester if the withdrawal takes place on or after week 3 of the semester.

The following timeline will be used to determine the amount of the tuition refund available to the student who withdraws from the program. Tuition is paid by the semester. **Tuition only will be refunded.** Additional expenses are not included in the refund.

Week 1	100%refund
Week 2	50%refund
Week 3 and after	0%refund

After last day to withdraw: no refund

The Coordinator of Registration and Enrollment (CRE) will notify and confirm with Watts Bursar and Student Information Services and Systems Office (SISS) student status in the program.

Administration will determine if an unpaid balance or learning resources is due upon withdrawal or interruption of schooling.

If the student is due a refund, any unpaid balance of learning resources will be subtracted from the refund.

If no refund applies, students are responsible for payment of any unpaid balance to the College or present proof of purchase of learning resources to Administration at the time of withdrawal or interruption of schooling.

TITLE IV

Return/Refund of Title IV Funds:

Return of Title IV Funds calculations are approved by and policy is maintained by WCON Financial Aid Office.

Changes to federal law may affect this policy.

Steps in Return/Refund Process:

1. Determine withdrawal date
2. Calculate the percentage of enrollment period completed
3. Calculate the amount of Title IV aid earned
4. Determine the amount of Title IV aid unearned
5. Allocate unearned aid
6. Title IV loan amounts to be returned by WCON will be credited to the appropriate Title IV programs
7. Communication of Returned Funds

1. Federal Direct Unsubsidized Loans
2. Federal Direct Subsidized Loans
3. Federal Parent Plus Loans

Financial policies, procedures and philosophies can be found in the Financial Aid Handbook.

SATISFACTORY ACADEMIC PROGRESS

To receive Title IV Federal Financial Aid at Watts College of Nursing, students must be in good academic standing, to be maintained at all times during the program. Satisfactory Academic Progress (SAP) is evaluated to ensure students complete their degree in a timely manner and the minimum requirements must be met to receive Federal Financial Aid.

Satisfactory Academic Progress is measured at the end of each semester by the following:

1. Semester Grade Point Average (GPA)
2. Pace - successful completion of a percentage of all attempted courses
3. Maximum time frame allowed to complete the program

1. Semester Grade Point Average

Semester Grade Point Average (GPA) - (Qualitative Measure).

If students fail to maintain a cumulative grade point average of 1.75 they will be placed on Financial Aid warning.

2. Pace

Pace is the successful completion of a percentage of all attempted courses - (Quantitative Measure). Students must successfully complete two-thirds (67%) of all attempted credits (cumulative). Failure to complete 67% will result in being placed on Financial Aid Warning. Transfer General Education courses and Watts College of Nursing courses both count towards pace.

Transfer General Education course credits with satisfactory grades are those for which a grade of A+/-, B+/-, C+ and C, are acceptable for pace attempt and completion. Except for non-credit remedial courses, any Watts College of Nursing course for which a student receives a grade counts as attempted, but only grades of A, B+,B, C+, or C count as attempted and successfully completed. All other grades, D+, D, F, I, W, count as attempted but not successfully completed.

Students who withdraw from a course or receive a course failure may repeat the course only once. A maximum of two courses may be repeated.

3. Maximum Timeframe

In order to continue to receive financial aid, a student must complete his or her program of study before 150% of the credits required to graduate have been attempted. Since 120 total credits (60 general education credits, 60 Watts College credits) are required to graduate, this makes the 150% point at 180 credits. Attempted credits from all enrollment periods plus all accepted transfer credits are counted. All terms of enrollment are included whether or not the student received financial aid and regardless of the age of the coursework.

SATISFACTORY ACADEMIC PROGRESS REVIEW

Satisfactory Academic Progress will be reviewed at the end of each semester. A student who fails to meet any of the standards described above will be placed on financial aid warning for the next semester, if the student does not meet SAP after the warning semester they will not be eligible for any Title IV financial aid, but may appeal to the Watts College SAP appeals committee. If the appeal is approved the student will be placed on probation or academic plan moving forward.

APPEAL PROCESS

A student who becomes ineligible for Title IV assistance should appeal the determination if they believe there were extraordinary circumstances that prohibited them from meeting SAP guidelines. A letter of appeal outlining the basis on which they are appealing the termination of federal student aid should be submitted by the student either in writing or via email directly to the Associate Executive of Business who will forward all information to the Watts College of Nursing SAP appeals committee. Students may also submit other documentation that supports their appeal from medical professionals, counselors, or other third party professionals (non-family members) who understand the details of the situation. Students should also include an explanation of what has changed in their situation that will allow them to demonstrate satisfactory academic progress at the next evaluation.

The appeal will be reviewed by The Watts College of Nursing SAP appeals committee who will review the student's academic progress in light of any extenuating circumstances and make a determination regarding whether the student's federal Title IV aid eligibility can be reinstated. The decision will be documented in the student's financial aid record.

FINANCIAL INFORMATION

FINANCIAL AID PROBATION AND ACADEMIC PLAN

If the appeal decision is to reinstate the student's eligibility for Title IV funds, the student may be placed on probation for one term on the condition that the student is required to achieve minimum SAP standards at the end of the probationary semester. If mathematically impossible to achieve the minimum SAP standards by the end of the probationary period but possible for the student to meet all SAP guidelines prior to their scheduled graduation date, the institution may place the student on an academic plan instead of probation. The Associate Chief Academic Executive will develop an academic plan that, if followed by the student, will ensure that the student is able to meet the university's academic progress standards prior to the student's scheduled graduation date and allow them to continue to receive federal financial aid funds.

The student may continue to receive Title IV aid during the probationary/academic plan term. If the student has not met satisfactory academic progress standards by the end of the probationary term, or if the conditions of the academic plan are not met each semester, the student will become ineligible for further Title IV aid until meeting SAP standards once again or they have submitted another appeal that has been approved. There is no limit to the number of SAP appeals a student may submit.

INCOMPLETES, WITHDRAWALS, NONCREDIT REMEDIAL COURSES, AND TRANSFER CREDITS

Courses with grades of (I)Incomplete or (W)Withdrawn will be counted as courses attempted but not completed. Noncredit remedial courses will be counted as neither courses attempted nor completed. Credits transferred from another institution shall be counted as both attempted and completed.

Repeated Courses

All Watts College of Nursing courses are given credit with an earned grade of C or better. A course grade of D+, D or F may be repeated only once as approved by administration with a maximum of only two courses may be repeated to remain in the program. The grade earned in the repeated course as well as the grade earned originally appear on the transcript; both grades count in the grade point average, but the credit for only one counts toward the required number of credits for continuation and completion of the 60 credit program required for graduation.

Loss of Financial Aid Eligibility

A student becomes ineligible for all federal student aid funds if Watts College of Nursing SAP review indicates he or she does not meet the required GPA, is not maintaining the required pace, has exceeded or is expected to exceed the permitted maximum time frame after exhausting the financial aid warning semester and has been unsuccessful in the SAP appeals process.

Communication of Status

Students will be notified via their Duke email account after the end of each semester if their financial aid status relating to SAP is unsatisfactory and they will be placed on financial warning or they have consequently lost eligibility to receive Title IV aid after not meeting SAP after financial aid warning semester. The process for appeal will be included in the email when notifying students that their SAP status is unsatisfactory after the financial aid warning semester grades post and student is still not meeting SAP.

After submitting a SAP appeal, students will be notified of the outcome within 10 business days via their Duke e-mail account. If the appeal is approved, we will communicate directly with the student whether they have been placed in a probationary status or academic plan status along with the associated consequences and requirements. If the appeal is denied, we will communicate this to the student as well including the reason why the appeal could not be approved.

FINANCIAL INFORMATION

VETERANS

Watts College of Nursing will certify to the Veterans Administration those students qualifying for educational payments under the policies of the Veterans Administration. These policies stipulate that the grade point average used in determining satisfactory progress must be based upon all courses attempted. The Veterans Administration requires a minimum of 12 credit hours per semester for payment of full-time benefits to veterans and eligible dependents. Transcripts are kept by the College of Nursing on veterans and non-veterans alike. Transcripts are furnished at the end of each scheduled school term.

It is urged that preliminary application for any educational benefits for veterans and children of deceased and disabled veterans be made to the nearest regional office of the Veterans Administration well in advance of the desired admission date.

A covered individual is any individual who is entitled to educational assistance under chapter 31, Vocational Rehabilitation and Employment, or chapter 33, Post-9/11 GI Bill benefits.

We will permit any covered individual who is an accepted student to attend or participate in the course of education during the period beginning on the date the individual provides to the educational institution a VA certificate of eligibility for entitlement to educational assistance under chapter 31 or 33 (a "certificate of eligibility" can also include a "Statement of Benefits" obtained from the Department of Veterans Affairs' (VA) website - eBenefits, or a VAF 28-1905 form for chapter 31 authorization purposes) and ending on the earlier of the following dates:

1. The date on which payment from VA is made to the institution.
2. 90 days after the date the institution certified tuition and fees following the receipt of the certificate of eligibility.

We will not impose any penalty, including the assessment of late fees, the denial of access to classes, libraries, or other institutional facilities, or the requirement that a covered individual borrow additional funds, on any covered individual because of the individual's inability to meet his or her financial obligations to the institution due to the delayed disbursement funding from VA under chapter 31 or 33.

Santa Filomena Honor Society

The Santa Filomena Honor Society is a service organization composed of second-year students chosen by the society members and faculty for qualities of leadership, excellence in academic and clinical performance, and contribution toward the betterment of the college and community. Each member must have a specific grade point average and have demonstrated a commitment to high professional nursing standards. Members are inducted into the society at the end of the second, third, or fourth semesters and may be identified by the small gold and blue pin on their uniform.

COURSE GRADE DETERMINATION

Course grade will be determined by calculating grades of predetermined weight for tests and designated learning activities that are calculated to the thousandth of a point. There will be no rounding of any grade. For clinical evaluations, each course objective must be appraised as "Pass" on the Summative Evaluation Form. If course objectives are not met, the course grade is an automatic failure. All course requirements must be met by the date

designated unless the involved faculty grants an extension. Incomplete (I) is assigned until all course work is submitted, evaluated, and graded. The final course grade must be submitted to the Coordinator of Registration and Enrollment prior to the first day of class for the next semester. Students who fail to complete work as designated will have (I) changed to a course grade of F in the student record.

ATTENDANCE

WATTS COLLEGE OF NURSING COURSE DESCRIPTIONS

CURRICULUM INFORMATION

The curriculum does not offer advanced placement. All students matriculate at the same level, regardless of prior educational programs. Each semester is 15 weeks in length.

CURRICULUM

The Watts College of Nursing curriculum provides the knowledge, skills, and professional attributes necessary to prepare a nurse generalist who is able to practice in a variety of health care settings with a diverse population of clients.

Progressing from simple to complex, the curriculum is based on core standards, guidelines, and competencies for nurses and health care providers set forth by the American Nurses Association (ANA), the Institute of Medicine (IOM), and the National League for Nursing (NLN), which are integrated into seventeen concepts. Using a lifespan approach in both years of study, the first year focuses on basic health assessment and nursing management of uncomplicated health problems.

The second year concentrates on nursing management of acute, chronic, and life-threatening health problems and the transition to nursing practice.

CREDIT HOUR DETERMINATION

Credit hours are assigned based on Carnegie units. One unit represents 50 minutes. One credit hour is recognized as 750 minutes. Credit hour formula for courses is: 15 hours of class = 1 credit hour, 3 hours clinical = 1 hour of class. Maximum course load is 15 credit hours per semester

Courses must be completed in numerical sequence and students must achieve a Course Grade of "C" or better to progress in the program. A maximum of one course may be repeated and all courses must be completed within 150% of the timeframe (maximum timeframe - Satisfactory Academic Progress Policy).

PROGRAM OUTCOMES

Upon completion of the program, graduates are eligible to apply to take the National Council Licensure Examination (NCLEX-RN).

GENERAL EDUCATION REQUIREMENTS

Each course must be passed with the minimum grade and number of credit hours indicated below prior to beginning the nursing program at Watts College of Nursing:

- English Composition I (C) 3 semester hours
- English Composition II (C) 3 semester hours
- Literature (C) 3 semester hours
- Speech Communication/Public Speaking (C)
3 semester hours
- Anatomy and Physiology I with a lab (C)
4 semester hours
- Anatomy and Physiology II with a lab (C)
4 semester hours
Human Anatomy and Physiology must cover all body systems, and be taken within five years of the date of matriculation into the nursing curriculum

PROGRAM OUTCOMES FOR WATTS COLLEGE OF NURSING

By the end of the program, the student will be able to:

1. Manage client-centered care, utilizing the nursing process, to meet the spectrum of health care needs of a diverse population across the lifespan.
2. Collaborate with clients, families, communities, and health team members in the promotion, maintenance, and restoration of optimal health.
3. Demonstrate professional accountability and commitment to compliance with professional performance standards of the ANA including quality, nursing practice, education, leadership, and research.
4. Provide safe and effective care, justifying clinical decision-making based on evidence from nursing and associated disciplines.
5. Manage informational and technological resources to coordinate, facilitate, and improve the quality and delivery of health care in a variety of settings.

WATTS COLLEGE OF NURSING COURSE DESCRIPTIONS

NURS 3000: Nursing Concepts I

7 credit hours (5 Theory, 2 Clinical)

Prerequisites: *General education requirements*

This course will introduce the core concepts of the curriculum as applied to the care of individuals and families throughout the lifespan. Emphasis is placed on basic health care needs and associated nursing skills. The nursing process is presented as the basis for nursing practice. Theory and skills are reinforced in laboratory and clinical experiences in a variety of health care settings. Identification with the nurse's role is fostered by direct involvement and active participation in the nursing care of assigned clients.

NURS 3100: Nursing Health Assessment

3 credit hours (2 Theory, 1 Clinical)

Prerequisites: *General education requirements*

This course will address concepts and methods for comprehensive health assessment of clients across the lifespan. Emphasis will be on data collection as a basis for initiation of caring and decision making in nursing practice.

NURS 3200: Nursing Pathophysiology

3 credit hours

Prerequisites: *General education requirements*

This course will introduce the fundamentals of pathophysiology that are essential to understanding conceptual exemplars and the relationships that exist between concepts. Students will explore how clinical manifestations of disease, risk factors for disease and the principles of pathology relate to basic nursing practice.

NURS 3450: Introduction to Professional Nursing

2 credit hours

Prerequisites: *General education requirements*

This introductory course will introduce learners to the core values and professional standards of the Registered Professional Nurse. It will review the origins of professional nursing, the evolution of the professional nurse and relevance to current healthcare delivery. Content activities will expose students to issues surrounding the profession of nursing, clinical judgment, and nursing practice as it relates to the nurse, client, health and environment. Professional collaboration and communication with the interprofessional healthcare team members, legal influences, ethics and scope of practice will be explored.

CURRICULUM INFORMATION

NURS 3500: Nursing Concepts II

11 credit hours (8 Theory, 3 Clinical)

Prerequisites: *General education requirements, Nursing Health Assessment, History and Theories of Nursing, Nursing Concepts I, Nursing Pathophysiology and Pharmacology I, Nursing Research I*

This course will apply the core concepts of the curriculum to clients experiencing health concerns. The nursing process is utilized as a framework to address health promotion and disease management across the lifespan. The nurse's role as advocate, collaborator, and educator are expanded and professional performance standards of the nurse are integrated throughout the course. Clinical experiences afford students the opportunity to apply nursing in varying environments in which care is given.

NURS 3500

Prerequisites Spring 2024: *General education requirements, Nursing concepts I, Nursing health assessment, Nursing pathophysiology and Introduction to Professional Nursing*

NURS 3700: Nursing Pathophysiology & Pharmacology II: Last Offering of Course - Fall 2023

2 credit hours

Prerequisites: *General education requirements, Nursing Concepts I, Nursing Health Assessment, Nursing Pathophysiology and Pharmacology I*

This course will build upon fundamentals of pharmacodynamics, pharmacokinetics and pharmacotherapeutics of select classifications of medications as they relate to more complex pathophysiology seen in each body system. Pathophysiological disease processes and nursing concepts are integrated with each select classification of medications.

NURS 3700: Nursing Pharmacology (revised): First Offering of Course - Spring 2024

2 credit hours

Prerequisites: *General education requirements, Nursing Concepts I, Nursing Health Assessment, Nursing Pathophysiology*

This course will build upon fundamentals of pharmacodynamics, pharmacokinetics and pharmacotherapeutics of select classifications of medications as they relate to pathophysiology

seen in each body system and across the lifespan. Special considerations for the nursing role in developing a comprehensive approach to the clinical application of drug therapy are examined, including safe administration and monitoring the effects of pharmacotherapeutic agents.

NURS 3800: Nursing Research II: Last Offering of Course - Fall 2023

2 credit hours

Prerequisites: *General education requirements, Nursing Research I*

This course will explore the processes to evaluate practice concerns required to translate and integrate evidence into nursing practice. Emphasis is on evaluation and application of gathering scientific data processes to evaluate nursing evidence practice concerns. Focus is on an understanding of the methods of data collection and analysis.

NURS 3800

Prerequisites Spring 2024: *General education requirements, Introduction to Professional Nursing*

NURS 3800: Introduction to Nursing Research: First Offering of Course - Spring 2024

2 credit hours

Prerequisites: *General education requirements*

This course will introduce/review the steps of the research process, explore the difference in qualitative and quantitative research methodology, and explore research questions with regards to theoretical underpinnings. The main focus of the course is on the development of researchable nursing-related problems and the exploration and dissemination of available literature. Students will consider implications for nursing practice related to research findings. Ethical, moral, legal, and professional roles and responsibilities of the nurse will be threaded throughout the course.

CURRICULUM INFORMATION

NURS 4000: Nursing Concepts III

9 credit hours (6 Theory, 3 Clinical)

Prerequisites: *General education requirements, Nursing Health Assessment; History and Theories of Nursing; Nursing Concepts I & II; Nursing Pathophysiology and Pharmacology I & II; Nursing Research I & II*

This course will extend the core concepts of the curriculum to complicated health problems across the lifespan. Emphasis is on the use of the nursing process to clinically reason and prioritize client and family health care concerns. Transition to professional practice begins through further development of professional performance standards. Clinical experiences provide students the opportunity to apply and analyze nursing in varying environments in which care is given.

NURS 4200: Nursing Pathophysiology and Pharmacology III

2 credit hours

Prerequisites: *General education requirements; Nursing Concepts I & II; Nursing Health Assessment; Nursing Pathophysiology and Pharmacology I & II*

This course will apply prior learned concepts related to pharmacodynamics, pharmacokinetics and pharmacotherapeutics of select classifications of medications to complex pathophysiology seen in each body system. Pathophysiological disease processes and nursing concepts are integrated with each select classification of medications.

NURS 4300: Nursing Research III

2 credit hours

Prerequisites: *General education requirements, Nursing Research I & II*

This course will examine the processes required to translate and integrate evidence into nursing practice. Emphasis is on the identification of a nursing practice concern and the application of scientific evidence affecting the practice concern using the PICO methodology. Focus is on an identifying an evidence based practice concern utilizing the PICO methodology and developing PICO statement based upon an extensive review of the literature support evaluating the practice concern. A tentative implementation plan will be developed and collaborative partner identified. This course is part 1 of a 2 part capstone project.

NURS 4400: Leadership and Management in Nursing

2 credit hours

Prerequisites: *General education requirements; Nursing Concepts I & II; Nursing Health Assessment, Nursing Pathophysiology and Pharmacology I & II*

This course will introduce concepts of leadership and management in nursing. Theories of management, leadership, and organizational behavior relevant to nursing are explored. Change and power theories, models of nursing care delivery, delegation, professional role development and models of quality management are emphasized.

NURS 4500: Nursing Concepts IV

5 credit hours (5 Theory)

Prerequisites: *General education requirements for admission to program; Health Assessment; History and Theories of Nursing; Nursing Concepts I, II, & III; Nursing Pathophysiology and Pharmacology I, II & III; Nursing Research I, II, & III; Leadership and Professional Issues/Trends*

Prerequisites OR co-requisites: *Nursing Research IV, Legal and Ethical Issues in Nursing*

Co-requisites: *Senior Seminar, Capstone Clinical*

This course will complete the expansion of the core concepts of the curriculum to apply to clients, families and communities across the continuum of health care. Emphasis is placed on the utilization of the nursing process in the role of manager of care. The design facilitates the completion of role transition from student to nurse generalist.

CURRICULUM INFORMATION

NURS 4600: Senior Seminar

1 credit hour

Prerequisites: *General education requirements for admission to program; Health Assessment; History and Theories of Nursing; Nursing Concepts I, II & III; Nursing Pathophysiology and Pharmacology I, II & III; Nursing Research I, II & III; Legal and Ethical Issues in Nursing*

Prerequisites OR co-requisites: *Nursing Research IV Legal and Ethical Issues in Nursing*

Co-requisites: *Nursing Concepts IV, Capstone Clinical*

This course will be a discussion based experience held in a seminar format for senior students engaged in precepted clinical learning experiences in the final semester. Students will interact with peers and faculty to examine clinical experiences in the transition to nursing practice.

NURS 4650: Capstone Clinical

5 credit hours (5 Clinical)

Prerequisites: *General education requirements for admission to program; Health Assessment; History and Theories of Nursing; Nursing Concepts I, II & III; Nursing Pathophysiology and Pharmacology I, II & III; Nursing Research I, II & III; Leadership and Management in Nursing*

Prerequisites OR co-requisites: *Nursing Research IV, Legal and Ethical Issues in Nursing*

Co-requisites: *Nursing Concepts IV, Senior Seminar*

This course will be focused on the preparation of the student for transition to professional nursing practice, leadership and management of care for individuals/groups of clients in a variety of health care settings. Emphasis is placed on applying the concepts of patient-centered care, information management, professionalism, interprofessional collaboration, ethical decision making, quality/safety, and lifelong learning.

NURS 4800: Nursing Research IV

2 credit hours

Prerequisites: *General education requirements, Nursing Research I, II & III*

This course will examine the processes required to translate and integrate evidence into nursing practice. Working with a collaborative partner to gather data and evaluate the impact of the implementation of an evidence-based practice strategy to address the concern. The PICO methodology will be utilized to carry out this evaluation of the practice concern. This course is Part 2 of a capstone project.

NURS 4900: Legal and Ethical Issues in Nursing

2 credit hours

Prerequisites: *General education requirements; Nursing Concepts I, II & III; Nursing Health Assessment, Nursing Pathophysiology and Pharmacology I, II & III, Leadership and Management in Nursing*

This course will examine legal and ethical issues that impact contemporary nursing practice. Primary focus is on ethical decision making processes and recognition of responsible practices as it relates to working within the complex healthcare environment. Through the use of case analysis; ramifications of professional behavior will be explored.
